Veteran Dogs will show in regular classes and are allowed to jump 4" lower.

Rent a ring after the trial at \$1.00 a minute with a max time of 10 minutes per dog to be scheduled on sign up sheet and paid prior to the run. No food or treats in the ring. Nothing distracting will be allowed in the ring.

Entry Forms can be found at www.asca.org/formsandrulebooks Please type (preferred) or print clearly and confirm they're signed and phone #'s and registration #'s are correct. Not using correct forms will delay your entry. Please include your dog's jump height if entering Open, Utility and or Grad Novice. All entries **must** include a copy of dog's registration certificate.

Move ups: 5-7pm the night prior. No Day of show Move ups. Armband pick ups 8-8:20 am

Pre entries must be post marked no earlier than 7/1/2017 and no later than 9-30-2017, unless limits are reached and a 3rd Judge is not available. No Judge will Judge more than an 8 hours.

Regular Classes: Prices are for each class and each Trial.

Brace & Team: Separate forms for each dog must be used.

If entered in a Regular class: \$10. Otherwise: \$15.

All dogs will be performing in the ring at one time. A double ring will be use if entries warrant. Teams will heal and perform exercises called out prior to the music starting. When the music stops, the exercise will be performed. Any Team not performing the exercise correctly or quickly enough, (last one to do so), will be asked to leave. Judges decisions are final! This class will be judged by volunteers and safety will be watched closely. This class will be done ON lead. This class is to motivate, HAVE FUN IN the Ring and to support Obedience and cancer research. ANYONE can enter, From a highly skilled to a NEW Beginning Team!

Checks will be deposited any time after 7-20-17

Pre-entries will be refunded only upon written request and postmarked by 9-30-17.

Any check resulting in insufficient funds will invalidate all entries and wins associated with that check. ASCSFL will add a \$35.00 collection fee to the amount of each returned check. If pre entry check does not clear, your entry is invalid until fee is paid by money order or cashier's check and you may lose your spot if Trial fills.

If your night before entry check does not clear and is not paid by November 5th, 2017 with a money order or cashier's check, it will be turned over to the ASCA Business Office and ASCSFL's Attorney. Any and All wins and or qualifying scores will become invalid.

This event will be held under the current rules and regulations of the Australian Shepherd Club of America (ASCA). No entry will be accepted from a dog or handler disqualified from all ASCA programs; or a person not in good standing with ASCA. ASCA rules require each dog entered to be ASCA registered. For more information on registering your dog with ASCA or for an official Obedience entry form go to www.asca.org "Day before" entries taken if entry limits are not reached by closing date. Please include your email address on your entry form. Day before entries may require class times to be adjusted. All Obedience dogs must have an ASCA CD before entering Open and have an ASCA CDX or ODX before entering Utility.

PLEASE PICK UP AFTER YOUR DOG AND OBSERVE THE 10' RULE WITH NO FOOD AND TREATS.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by a veterinarian or judge, or barred from competition by action of the Show Committee or ASCA Board of Directors. If, because of riots, civil disturbances, or other acts beyond the control of management, it is impossible to open or complete the show, no refund of entry fees will be made. Move-ups will not be allowed the morning of the event.

Substitution entry's for Bitches in Season will be allowed with an additional \$10.00 fee per class and will only be accepted during the Oct. 27th entry time. All entry stipulations must be met prior to entry being accepted.

ASCSFL, ASCA and Brazos County Expo assume no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, or to any of their dogs, personal property, and/or children. Children are to be supervised at all times. Dogs NOT entered are NOT are to be near or in any ring during the trial times.
