NO ENTRIES WILL BE ACCEPTED THAT REQUIRE A SIGNATURE. IF YOU USE OVERNIGHT MAIL, YOU MUST WAIVE SIGNATURE.

For immediate confirmation of receipt, please enclose a stamped, self-addressed postcard. Confirmation of receipt does not constitute an accepted entry. Acknowledgment of entries will be made after close of entries. Please make sure entries are legible and correct. **The age will be calculated as of October 27, 2017.** Dogs must be over six months of age to be eligible to compete. All entries must have an ASCA number; no pending numbers will be accepted. Entrants are responsible for errors on entry forms and no entry fee will be refunded in the event of such errors. No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. No entry shall be accepted from a dog or handler disqualified from all ASCA programs; or a person not in good standing with ASCA.

Foreign entries must be paid with funds drawn on a U.S. bank or by PayPal. For more details about PayPal payment please visit our website or email, Pam Riney pamjriney@gmail.com. DO NOT SEND CASH. Entries received without proper fee payment will not be accepted. Returned checks do not constitute a valid entry, and an NSF fee of \$35 will be charged.

Cancellation Policy:

Cancellation of pre-entries no later than 7 pm on September 30, 2017. No refunds will be given for requests postmarked after September 30, 2017. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by a veterinarian or judge, or barred from competition by action of the Show Committee. If, because of riots, civil disturbances, or other acts beyond the control of management, it is impossible to open or complete the show, no refund of entry fees will be made.

The dock will be outside. Please be aware of all weather. Dock will be open in rain but not thunderstorms. This is an ASCA sanctioned event and will be governed by the rules of the Australian Shepherd Club of America®.

Heart of Texas ASC, ASCA and Brazos County Expo assume no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, or to any of their dogs, personal property, and/or children. Children are to be supervised at all times.

Note to exhibitors:

- **Open Dock** - you pay a \$15 per dog / per day practice fee, and you can practice all day in between competition rounds. You'll get in line with everyone else, take 2 jumps, then get back in line. If you're brand spankin' new, we can help you get started, as long as it's not a crazy full event. When you get to the event, just find the event secretary's tent and ask her if there is availability. You will be asked for your name and signature for the liability waiver, & anyone else that will be going on the dock with you must do the same. NOTE: You do not have to be a registered competitor to come out and practice, but we highly encourage your dog to be a swimmer!
- Make sure to let the trial chair/check in person know that this is your first time, and please try not to be intimidated... we were all in your shoes at one time or another, and before you know it, you'll know everyone's name and hopefully you'll be coming to as many events as you can because you and your dog will be hooked!
- Dock will be portable 40' normal dock.

AGREEMENT

The person who signs this agreement represents that he/she is authorized to enter into this agreement on behalf of both exhibitor and the owner of entered dog. In consideration of acceptance of this entry:

- 1.1 As used here, "ASCA®" means the Australian Shepherd Club of America®, its affiliate clubs and each of their members, officers, directors, employees, show chairs, show committees, and agents.
- 1.2 Exhibitor/owner agrees to abide by the rules and regulations of ASCA® and any other rules and regulations appearing in the premium for this event.
- 1.3 Exhibitor/owner certifies that the entered dog is not a hazard to persons, dogs, or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.
- 1.4 Exhibitor/owner acknowledges all hazards presented by the event and the event premises, including, but not limited to: the condition of the floors, stairways, halls, lighting, security measures (or lack thereof), electrical appliances, fittings, show rings, parking areas, and the presence of unfamiliar animals and people. Exhibitor and owner assume the risk of any harm arising from these.
- 1.5 Exhibitor/owner releases ASCA®, the ASCA® affiliate club (including its officers, directors, members, and event organizing committee), and site owner(s) harmless from all present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, the event, or event premises. Without limiting the generality of the foregoing hold harmless provisions, exhibitor/owner hereby specifically assume sole responsibility for, and agree to indemnify and save aforementioned parties harmless from, any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damages because of bodily injuries, including death, at any time in consequence of my (our) participation in this event; howsoever such injury, or death, may be caused, and whether or not the same may have been caused, or may have been alleged to have been caused, by negligence of the aforementioned parties or any of their employees or agents, or any other persons.
